Public Comments:

Verna Larkin, 180 Preston Drive, stated she attended the Commissioners meeting May 8, 2018 regarding an abandon house located on Preston Drive. She was told at the meeting that it would be taken care of. Ms. Larkin stated, nothing has been done. The abandon house is an eye sore, a nuisance, and it is bringing the property value down. People are going in and out of the abandon house and kids are playing at the house. Someone is going to get hurt or killed. She said when she moved to Preston Drive 30 years ago it was a beautiful area.

County Manager Michael Dinnerman state he is familiar with the property. In 2018, proper staff was not in place and the County depended upon the City of Fitzgerald Code Enforcement. The County has since staffed its own Building and Zoning. This will be a process.

Commissioner Bennie Calloway stated several people has tried to buy the property; but the owner did not respond to their request.

Mr. Dinnerman stated the County may have to process this through the Court.

Chairman Steve Taylor stated they are listening and will look back into the issue.
